Mode of delivery

This is a hybrid course where we will meet on campus two times a week. Beyond our time together, you will complete additional work online.

Course description

This class is designed to introduce students to the central conceptual, theoretical, and applied issues in the study of persuasion. In particular, students will gain familiarity with 1) major classic and contemporary theories of persuasion; 2) key terms used by social influence researchers and practitioners, 3) common heuristics, or simple decision rules, that guide the decision-making process, and 4) ethical implications associated with persuasive attempts.

Students should complete the class not only with a strong understanding of persuasion theory but also with the ability to recognize persuasive appeals, to understand the underlying mechanisms through which they operate, and to construct effective persuasive messages for both interpersonal and mass media contexts.

Course learning outcomes

- 1. You will learn to demonstrate an understanding of the theories of persuasion.
- 2. You will learn about and apply ethical principles of persuasive messages.
- 3. You will demonstrate an understanding of persuasive messages and be able to explain why they work or fail using persuasion research and theory.

Proctorio

Proctorio, an online proctoring tool, will be used during this course. COURSE DESIGN

Credit hour and work expectation

This is a 3-credit-hour course. According to Ohio State policy, students should expect around 3 hours per week of time spent on direct instruction (instructor content and Carmen activities, for example) in addition to 6 hours of homework (reading and assignment preparation, for example) to receive a grade of (C) average. Please note: Carmen Canvas, OSU's grading and class management software, does not round fractions up. Please take that into account in computing grades. I do not manually round up grades. There will be opportunities for extra credit for students who choose to earn those points.

Extra credit

You can earn up to 2% of extra credit by earning up to 4 points of extra credit.

Students may earn up to **three points** of extra credit by participating in the School of Communication's Communication Research Experience Program (C-REP). ASSIGNMENT OVERVIEW

Descriptions of major course assignments

Readings

Reading prior to class is a requirement. The required readings are designed to be a starting point for our class discussions and activities. If you do not read before class, I will have less to talk about that will interest you and you will have fewer questions for me. In addition, you will be unable to participate in many of the in-class assignments without having read the assigned reading before class. Finally, reading the assigned text prior to class will help you to do well on daily lecture quizzes.

Exams

There will be two exams based on material covered in class and in the assigned readings. The exams are not cumulative. Both lecture material and reading assignments will be tested.

Exams will be composed of multiple-choice questions.

In-class participation assignments

You will regularly be asked to complete in-class assignments to illustrate course concepts. Some assignments will be carried out individually while others will be completed in a group. Most of these assignments will be finished entirely in class. They will be graded based on completion.

Because many of these assignments necessitate participation in the group discussion and activity, **they cannot be made up** if you need to miss class for any reason. However, I will excuse two in-class assignment absences, providing you with a cushion should you need to miss a class for any reason.

If you need to miss more than one class period due to an illness or other emergency, please be in touch with me immediately so that we can work together to find a solution. This opportunity to make up assignments will only be considered if the illness or emergency situation is brought to my attention within 48 hours of the missed class.

Online assignments

There are 6 online assignments throughout the semester. You will supplement the readings and class lecture with an online assignment. These assignments will ask you to further engage with the topics, typically through the application of a course concept or through the analysis of the topic in a novel context.

Comprehension quizzes

We will start most lectures with a short review quiz on the prior weeks' materials. The results of these quizzes will let us both know what information may need review. These quizzes will also familiarize you with the kinds of questions that will be on the exam.

Final project

You will create a print public service announcement (PSA) concerning a social issue connected with a real-life non-profit organization. The PSA design must be informed by one of the theories or persuasion principles we learn in the course. The final project consists of the following:

- An executive summary of your idea and the theory applied
- A print PSA that follows the strategies outlined in the executive summary
- A presentation in which you will provide an overview of your theoretical background and show the PSA in class. You will also be asked questions.

Late assignment policy

Assignments & Deadlines

Each assignment is due on the designated date. Late assignments are marked down 10% per day *including weekends*. If, however, you have an emergency or illness that precludes you from meeting a deadline, please let us know that right away. Provided that the emergency is brought to my attention within 24 hours of the deadline and can be documented, late penalties may be waived.

Technology issues

It is your responsibility to have consistent access to a reliable Internet connection and all required software noted above. You should build in extra time to resolve technical problems so that you are able to do that while still meeting deadlines. For assistance with tech issues, please contact OCIO (details provided below in section on technology). Deadlines will **<u>not</u>** be extended for technological problems. Technical failure does not constitute an excuse for submitting work late.

Technical problems which are documented by the University's Office of the Chief Information Officer (https://osuitsm.service-now.com/selfservice/system_status) will be permitted as these are outside of your control. If you experience a problem with an OSU system (email, Carmen) which OCIO have not reported, it will be your responsibility to raise a ticket with them. Exams

All exams are to be taken online, in class, using Proctorio, on the designated exam dates. The exam may be taken at an alternative time when approved by the instructor for one of the following reasons: (a) the absence is a university excused activity, necessary documentation is provided, and arrangements for make-up are made in advance; or (b) the absence is due to a medical or family emergency, necessary documentation is provided, and arrangements for makeup are made within 24 hours of the missed exam. If the requirements for (a) or (b) are not fully met, you will receive 0 points for the exam. Please note that make-up exams may be of a different format or cover course content in a different ratio than the original.

"Freebie" policy

You are allowed one "**freebie**" over the course of the semester, such that you can turn in an assignment late with NO PENALTY. To use your freebie, you **need to email me within one day** of the assignment due date that you're using your freebie (you do not need to tell me why) and **share the day you will submit it** (you can have up to two additional business days to complete the assignment). Requests alone will not be accepted. Part of this policy is to learn how to set our own schedule and expectations. Once you use up your freebie, you will receive the late penalty on any assignments. Freebies are applicable to discussion posts and final drafts of papers.
